EVELYN SILVA SCHOLARSHIP AWARD OF EXCELLENCE

ELIGIBILITY CRITERIA AND APPLICATION 2024 - 2025 ACADEMIC YEAR



The Evelyn Silva Scholarship Award of Excellence (ESSAE) was established in 2010 to honor Mrs. Silva, a longstanding member and pillar of the Enlisted Spouses' Club, now the Fort Meade Spouses' Club (FMSC) and Fort Meade community.

The award recipient must be a graduating high school senior who best exemplifies Mrs. Silva's passion and dedication to serving her community. After the **March 22, 2024** postmark deadline, the scholarship committee will evaluate the completed application package.

Potential scholarship candidates will be contacted at the end of March by the Scholarship Director to schedule an in person interview. These in person interviews will be held in April on Fort Meade.

This scholarship will be applied to the 2024-2025 academic school year. All eligible students are encouraged to apply for this competitive scholarship where one recipient will be selected.

If you are not selected for the ESSAE, this application will automatically serve as your application for the Fort Meade Spouses' Club Scholarship. Final results of the ESSAE shall be declared at the Annual Scholarship Awards Ceremony in May where all scholarship winners shall be recognized.

Eligibility Criteria:

- The applicant must be a dependent child (unmarried) of any military member from any branch, active duty, retired, deceased military personnel, Reservist or National Guard, not to exceed 23 years of age.
- ❖ Military members must live in the Fort Meade Area. Applicants must verify military dependency status.
- Graduating high school senior spring 2024.
- ❖ Minimum 3.0 GPA
- ❖ Must be enrolling as a full time post-secondary school student.
 - To qualify as a full-time student, a minimum of 12 credits each semester for the academic year of the scholarship is required.
- Submit a completed application on time as per details below.
- **Show continued volunteer experience with one or more organizations.**

Financial Restrictions:

Additional financial restrictions and obligations:

- 1. Scholarships will be payable directly to the school for tuition only. Scholarships will be paid when the FMSC receives a detailed statement of all financial activity on the student's account, to include hours enrolled, tuition and general institution fees, and any scholarships or grants.
- 2. Winners have until **August 1, 2025** to submit a bill from their school. Unclaimed funds will be retained by the FMSC.
- 3. Failure to submit documentation on time will result in forfeiture of scholarship.

- 4. Tuition will be paid directly to the school after the Scholarship Director has verified that all financial restrictions and regulations have been met.
- 5. If a scholarship winner receives 80% tuition money from other scholarships, tuition assistance, GI Bill, Post 9-11 GI Bill transfer, or any other sources that do not require repayment, the scholarship winner will become ineligible for the scholarship.
- 6. Scholarships may be used at any accredited college, university, business or vocational school for one year not to exceed the amount awarded.

Please select one (1) question and answer with a minimum 1 ½ page response. o What helped you make the decision to start volunteering or how did you get started in this field? Is there any advice or help that you could offer others who came to you wanting to start their own journey as well? o Relate to us a time where you found yourself in a situation where you were outside of your normal comfort zone and had to face the challenges this presented. How were you able to adapt or what strategies were you able to use to make it through, and what was the outcome?
Proof of Military Status o DD214, DEERS enrollment, copy of orders, letter from command or other documentation.
 Two proofs of sponsor residency in the Fort Meade area: One copy of a rental, mortgage, lease agreement, housing contract or property tax. One copy of the top portion of a cable, landline, or home utility bill, bank statement, or credit card bill (with account numbers blacked out.) Cell phone bills are not acceptable as proof of residency.
Two recent letters of recommendation from a non-family member. The first letter is required to be from a supervisor where you have volunteered on an ongoing basis. Letter must include your responsibilities and how long you have been a volunteer with them, for verification purposes. The second letter may be from a community organization leader, educator, employer, fellow volunteer or volunteer supervisor describing your character and/or participation with the organization from which they know you. ☐ Please be sure that the letters include the contact information of your references. Letters must be received by the deadline for scholarship applications. (Note: Letters of recommendation cannot be accepted from members of the FMSC Scholarship Committee or other applicants for this scholarship.)
SUBMIT OFFICIAL TRANSCRIPTS for your junior year and first semester of your senior year. Home school students: transcript submitted by the parent/guardian of the homeschooler
